About SJSC "State Real Estate"

SJSC "State Real Estate" (SRE) is the largest manager of Latvia's greatest assets – land and buildings. Land and cultural heritage, old and modern buildings, state border and customs infrastructure – all of these are national treasures for the people of Latvia.

Our vision is a modern and efficient working environment for public administration. The public sector today is aware of the importance of working efficiently, and this also applies to the use of real estate. SRE currently continues works on 54 different construction sites of national importance, with a total project budget of 223 million euros. The gates of Daugavpils have three symbolic keys, marked in the coat of arms of the city which was approved in 1925: a river, a Fortress and a lily, or, in other words, a road, a house and a prayer. These are three concepts that are not related to any particular nationality, culture or religion, but confirm the general human values of the peoples living here.

"Is it reward or punishment that Daugavpils has its peculiar and special fate and place in Latvia? This fate is closely linked with the Daugava, the river of fate, the ancient amber route from the Varangians to the Greeks, on the banks of which a city has grown, which, in various variations and at different times, has borne its name: Düna (Dünaburg), Dvina (Dvinska), Daugava (Daugavpils). According to the ancient etymology, the hydronym Daug-ava means a lot, and Daugavpils is indeed a city rich in waters, rich in languages, culture, denominations, and fates, it is a city where multi-ethnical and multicultural environment has been developed since ancient times, accumulating as in a hope chest experience in how to bring together people of many nationalities and many faiths, how to stay yourself without disparaging and destroying the others."

About Daugavpils municipality

The representative of residents of Daugavpils city municipality is ensured by the elected decision-making body of the municipality – Daugavpils City Council. The City Council, in accordance with its competence, shall be responsible for the legal activities of its institutions and for the appropriate utilisation of financial resources.

The council consists of 15 members. The execution of the decisions of the City Council shall be ensured by officials elected or appointed by the City Council, local government authorities and their employees, as well as capital companies. Daugavpils Fortress – a unique tourism facility in the Baltic States

Daugavpils Fortress is a unique 19th century architectural and urban building monument. It is the last bastion-style Fortress constructed in the world. Daugavpils' Fortress area is more than 150ha and is located on both banks of Daugava. Looking at the Fortress from a bird's eye view, it resembles a silhouette of the sun, star, turtle or even a bat.

The construction of the 210-year-old Fortress in Dinaburga began in 1810, in preparation for the war with Napoleon. The construction of the Fortress was only completed in 1878, when the Fortress itself, like the fortifying structure, was already obsolete.

Today Daugavpils Fortress is one of the city's residential areas, with more than 1000 inhabitants. The Fortress is open to visitors free of charge 24 hours a day, every day. Fortress is a favorite place for walks, tours and various photo sessions and video shoots.

The most interesting sights of Daugavpils Fortress

- Fortress fortifications, main rampart.
- Daugavpils Mark Rothko Art Centre in the former Artillery arsenal.
- Water tower (1865-1866), currently Daugavpils Fortress Culture and Information Centre.
- Fortress gate, especially the neo-gothic Nicholas Gate, the Bat Centre and the souvenir shop.
- Guardhouse or kordegarde.
- The open-air art work "Ghost of the Fortress".
- The First World War Museum
 "Pie Komendanta".

- Art Gallery "White Horse", Salon Antique "Housevintage" and medical exhibition with an exposition of birth control items.
- 9 original 19th century cannons produced in Russian empire.
- Jesuit Collegium building the oldest stone building in Daugavpils.
- The building of the military hospital built in 1827, a memorial plaque dedicated to General Janis Balodis, etc.
- 7th Bastion Powder Cellar an exhibition hall of an outstanding Latvian ceramist
 P. Martinsons created within the project






